The Mensa Education & Research Foundation is a philanthropic, non-profit 501c(3) organization committed to the pursuit of excellence in the areas of intelligence. Its mission and strategic programs focus on **Scholarships** encouraging intelligence, **Research** supporting intelligence, **Education** communicating intelligence, and **Awards** recognizing intelligence.

The Foundation is governed by a Board of Trustees who are volunteers elected by members of the American Mensa Committee (AMC), the voting members of the Foundation. Funding support comes from American Mensa, Ltd., Mensa International, and other charitable donations.

Donations to the Mensa Foundation are deductible for income tax purposes.

The Mensa Education & Research Foundation and American Mensa, Ltd. share the vision of “assisting intellectually gifted people in the development of their intellectual and social abilities so that they can better benefit society.”

Mensa donor Russell F. Taptich shared the following comments after a conversation with me in December 2006: “You have a non-bureaucratic approach toward ‘doing’ something to benefit gifted children... The mission is daunting, not for lack of Mensa-level ideas, but for not having Bill and Melinda-level funding...”

“There are all kinds of things to be done in adult ‘reality,’ despite society’s current direction more toward training than education. A mentored smart kid can come to imagine that there’s little he/she cannot intelligently try to do, by being introduced to some of the infinite variety of things that are being done... The rewards, which may result after all of our times, may advance the Pursuit of Happiness for more of the world.”

An inherent benefit of your Mensa Foundation is to assure that desired uses of generous donations will be used for designated programs. In the United States, the charitable benefit is also recognized as a deductible amount for individual taxes.

IBD (International Board of Directors) delegates to the 2006 Mensa World Gathering in Orlando requested that the Mensa Foundation increase its international programs and provided funding to do so. Dr. Abbie Salny, International Honorary President, has dedicated her term to discussing the Mensa Foundation concept and programs during visits to several countries. Thank you, Abbie, for your considerable efforts in helping us achieve this goal.

The assets of the Mensa Foundation now represent approximately 30 percent of the combined assets of American Mensa, Ltd., and the Mensa Foundation, reflecting the strong commitment of our members to the vision as well as to specific programs. Recognizing the Exceptional

■ *Teaching*

Michelle Breuer-Vitt, a Latin teacher at Minnehaha Academy in Minneapolis, MN, was awarded the 2006 **Distinguished Teacher Award**.

Michelle (aka Magistra) was chosen for the award based on an essay written by Stephanie Long, a Mensa member and former student.

"I love teaching in a middle school because of the kids," Michelle says. "They have an excitement and a joy for life that is just fantastic."

In her nominating essay, Long wrote, "While other teachers' names and subjects fade in memory, Magistra's will continue to last.

As for me, the love of language that Magistra instilled

in me led to a degree in linguistics.

"And even today, as a law student, I still hear her voice every time I come across a Latin legal term, of which there are many. Latin may be a dead language to some people, but to those of us who saw it come alive, it never will be. And because of her, I will always smile and remember that no language, memory or experience is dead, so long as it's remembered and loved."

The Distinguished Teacher Award recognizes a teacher, professor, or instructor at any educational level who has had an especially positive influence on the education or life of a Mensa member. The educators can impact the Mensa member directly or as a result of their influence on the education of a dependent.

The teacher selected for the award is presented with a plaque and a monetary award from the Mensa Education & Research Foundation.

■ *Communication*

Carolyn Jack was awarded the **Mensa Press Award** for a seven-part series of articles on human creativity, "The Work of Art," published during July 2005 in the *Cleveland Plain Dealer*. Carolyn was the arts writer for the newspaper at that time.

This award recognizes excellence in writing about human intelligence and giftedness in media designed for lay audiences

From the nomination letter, "More and more, experts are finding that the value of the arts far exceeds mere diversion: Recent research reveals a strong correlation between arts experiences and the kinds of brain activity necessary for heightened general intelligence, academic achievement, emotional well-being, workplace productivity, and social engagement."

Carolyn noted, "Realizing that many among our readership regard the arts as having little or no consequence in their lives, I thought it might be interesting for them to see evidence of the role creativity plays in any kind of activity or occupation, even the most ordinary. I undertook the series to explain in simple terms the scientific origins and functions of the arts; how they are at once the result of, and an influence on, humans' evolving intelligence; and the impact arts-related skills have on our daily lives."

■ *Intellectual Benefits*

The first **Intellectual Benefits Award** goes to **Karl Albrecht**. The Foundation's newest award program recognizes a Mensa member for the application of intellectual abilities that result in a tangible benefit to society.

Karl won the award based on his book, *Social Intelligence: the New Science of Success*. The book discusses how social intelligence is key to success at work and in your personal life. Foundation



President Greg Timmers noted in his letter to Karl, "The Mensa Foundation has utilized and personally thanks you for your work and recent book... Interestingly, the Mensa Foundation Articles of Incorporation, dated March 1, 1971, include as a purpose, 'Assisting intellectually gifted people

in the development of their intellectual and social abilities so that they can better benefit society."

Karl Albrecht is a management consultant, futurist, speaker, and prolific author. In his 20-year career, he has worked with many kinds of business organizations in a broad range of industries worldwide. He has consulted with senior executives, lectured to audiences on all inhabited continents, and authored more than 25 books on various aspects of business performance.

The **Awards for Excellence in Research** are given internationally for outstanding research on intelligence, intellectual giftedness, and related fields. Eligible research is that first published in or accepted by a peer-reviewed journal, or presented at a peer-reviewed professional conference. Who's Who in Scholarships

Stuart Friedman, for whom one of this year's Mensa Member scholarships is named, writes, "Over the years, in addition to co-founding MERF, I've served in many capacities, elected and appointed. Many of these were personally very rewarding but none matched the pleasure of being the recipient of this acknowledgement."

Helen Kupper's 80th birthday was marked by the creation of the Helen Kupper Scholarship for the study of Fine Arts. People in her local Chicago Area Mensa group and others with the Mensa Foundation

worked to raise the \$20,000 to endow this scholarship in perpetuity.

Helen has been very active in Mensa and served in many roles at the local, national, and international level. She was appointed by Mensa International as the U.S. person in charge of the 50th anniversary celebrations in 1996.

Dr. J. F. Schirmer was a Mensan from San Antonio who wanted to help college students attain their goals and saw the Mensa Foundation as the way to do it. A few years before his death, he revised his will to include a substantial bequest for the establishment of a scholarship that would be renewable for each of a student's four years in college.

Colloquiums

Stimulating Thinking

Colloquiums examine contemporary issues in depth with authoritative speakers and discussions. Two colloquiums were held in the last year. In the works for early 2009 is a colloquium on climate change.

■ *Revolution in Cosmology*

Colloquium 2006 was presented on October 6–8 in Albany, NY, and chaired by Judy Keating and Harry Ringermacher.

Attendees learned about the recently discovered accelerating universe and “dark energy” responsible for it, galaxies surrounded by invisible “dark matter,” extra dimensions, string theory, loop quantum gravity, and more.


A sold-out event hosted world-renowned scientists and authors: Brian Greene, physicist known for his superstring theory; Jeremiah Ostriker, a dark matter/dark energy expert and an influential researcher in astrophysics; Vera Rubin, an astronomer known for her research of dark matter in galaxies; Lee Smolin, theoretical physicist and creator of the loop quantum gravity theory; Marc Millis, NASA rocket scientist; and George Musser, editor and contributing writer for *Scientific American*.

This Colloquium was presented by Mensa of Northeastern New York, the Mensa Education & Research Foundation, and American Mensa, Ltd.



■ *Aspects of Humor: The Art and Science of Laughter*

“Comedy and humor. Art and science. Observation and participation.” These words welcomed attendees to **Colloquium 2007**, held March 23–25 in Oak Brook, IL, and chaired by Chris Edwards.



Throughout the weekend, participants explored the social and psychological functions of laughter and comedy, the techniques of their generation, and their practical applications. Light moments were mixed with a serious look at how humor fits into the ordinary and extraordinary facets of our lives.

Highlights included keynote speaker Merrill Markoe, original head writer of “Late Night with David Letterman” who garnered five Emmies. John Vorhaus, author of “The Comic Toolbox,” shared his tools, techniques, and tips for writing comedy. Mensan Rubi Nicholas, winner of “Funniest Mom in America 2,” demonstrated how a unique point of view, friendly style, sense of timing, and charisma bring people together as they find common ground.

The event was presented by Chicago Area Mensa with support from Mensa Education & Research Foundation, American Mensa, Ltd., and a generous donation from the GOBS (Good Old Burton Spain) trust.

Gifted Children

Nurturing the Future

The Mensa Foundation has taken several steps to increase its support of gifted children and related programs. Highlights include:

- Supported cost of membership in National Association for Gifted Children (NAGC) for approved Local Gifted Children Coordinators; coordinated with American Mensa’s Gifted Children Program to set up the NAGC memberships.
- Approved an annual grant of \$500 for materials for the conduct of a Gifted Children’s program at the Annual Gatherings of American Mensa. The program, currently called Kids Trek, has been enormously successful with the oversight and dedicated volunteerism of Mensa member Martha (Feld) Williams.
- Launched the Mensa For Kids website (at www.mensaforkids.com), providing funding for the 2007–2008 year. The site includes a feature of the month, educational games, and activities geared for children 6–10 years old, plus a variety of resources for teachers and parents.

Mensa Research Journal

Understanding Our Community

The *Mensa Research Journal* (MRJ) publishes articles on recent findings in intelligence research from nationally and internationally esteemed scholars.

Themes for 2006–2007 included chemical abuse and IQ, including why the brain becomes addicted; intellectual property in the 21st century; spatial intelligence; and a supplemental issue on fibromyalgia and fibrofog by past editor Dr. Shirley Loges.

The MRJ also includes book reviews, a column of recommended websites and other resources dealing with intelligence, and information about events.

Upcoming themes include “What is ‘g’?” and an issue on homeschooling.


This past year saw the addition of four members to the editorial board as well as two assistant editors on the MRJ staff. Book reviews became a more visible part of each issue.

The MRJ’s mission is to seek and publish current research that addresses the development, measurement, education, preservation, enhancement, or loss of intelligence. Tangential issues or concerns related to cognition or intelligence are also explored.


Financials in Brief



Donor Spotlight: Martin Zwart

A gifted man made a gift, and thousands of gifted children will benefit.



Martin Zwart, a longtime member of Chicago Mensa, was a professor of linguistics who spoke seven languages, a passionate stamp collector, and an avid reader with thousands of books. Although some may know him as the model for the cover of a past *Mensa Research Journal* issue devoted to articles on intelligence and the elderly, he was more interested in gifted children. He decided to put that

interest to use by including a bequest in his will for the Mensa Foundation.

Martin died in 2004 and, upon the settlement of his estate, the Foundation received a donation of more than \$90,000 designated to benefit gifted children. A portion of those funds are now being used to support the new Mensa For Kids website; more projects will follow.

As do many of our donors, Martin Zwart chose to make a difference with something that mattered to him. Thank you, Martin.


